Croydon Road Slip Road by Marlborough Court

Following concerns raised by residents, Westerham Town Council have been reviewing the Croydon Road access road by Marlborough Court. With cars parked along one side, the road is only wide enough for one vehicle and concerns have been raised as to safety of drivers and pedestrians. A proposal to make the Croydon Road service road one-way is being considered (see map: direction to be determined by Kent County Council Highways Engineers if the one-way is agreed to in principle).

This is an informal consultation to canvass local opinion. If there is no clear consensus, or a strong view that the road should not be altered then this proposal will be dropped. Either way, the outcomes of the informal consultation will be discussed in detail by Westerham Town Council.

Kent County Council are the highway authority and may make changes to the highway without our involvement (although we would be informed as a consultee). Kent County Council is expected to prioritise areas where road safety data indicates that Casualty Reduction Measures (CRM) would be warranted. Clearly, changes to road layouts (e.g. one-way streets) are just some of the tools that might be employed to improve road safety.

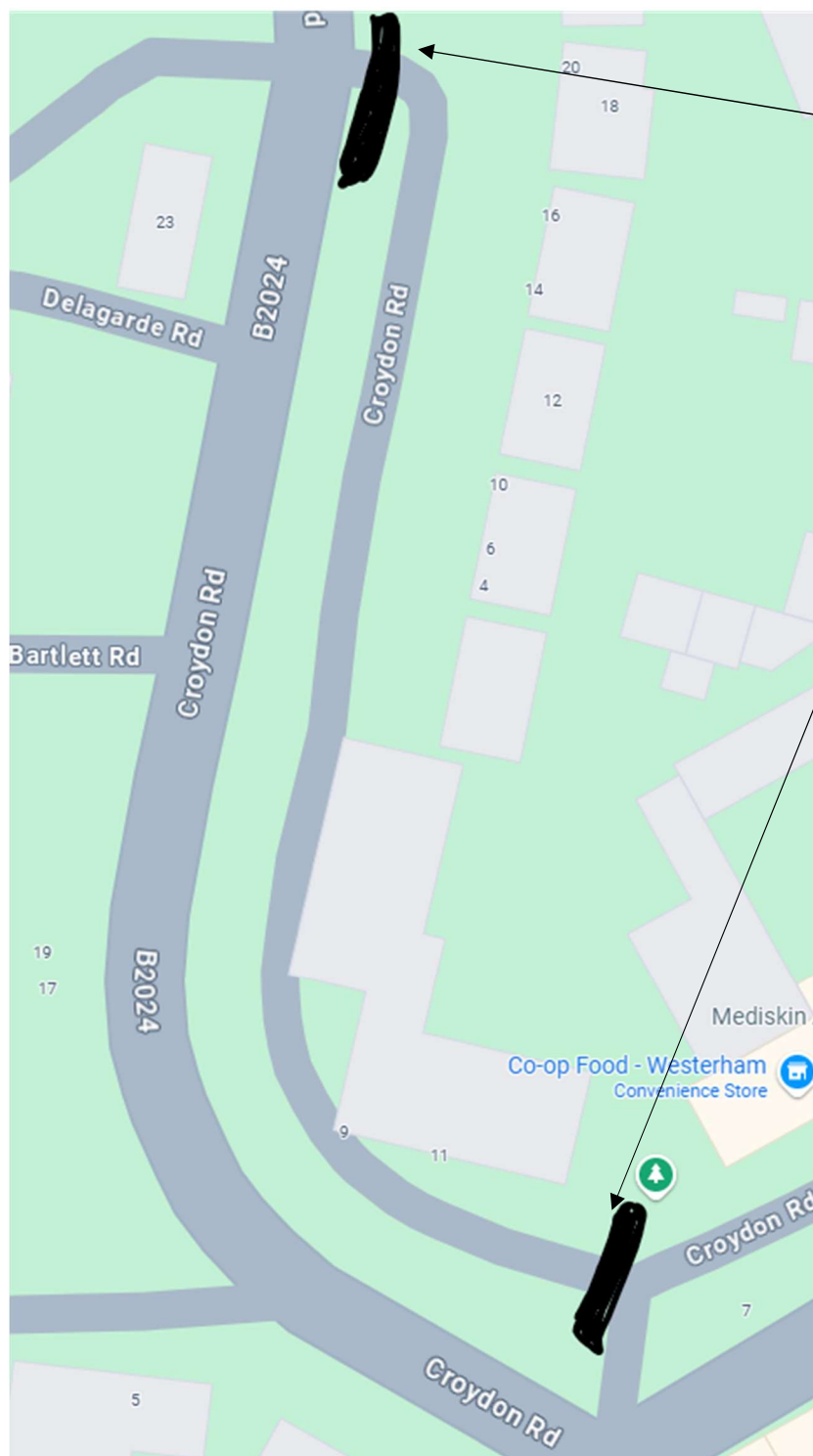
Placing new restrictions and amendments is quite a lengthy process. In part this is necessary, as this gives a chance to consult with those most likely to be affected by the changes, and to allow residents and important stakeholders (such as the police and fire service, for example), to respond or ask questions. Most changes to the parking and waiting rules requires a period of public consultation to allow for any objections and comments.
